#### Module 4

#### Clinical Reasoning Using Ayres Sensory Integration®

#### **Course Description:**

Module 4 focuses on clinical reasoning based on research and evaluation data to understand the findings and make recommendations for goals and services. Trainings leading to knowledge and skills in clinical reasoning allows the learner to understand relationships in the assessment data and relationship to participation, informing recommendations for services.

#### **Learning Objectives:**

It is intended that at the end of Module 4, participants will be able to:

- Describe the patterns of sensory integration function and dysfunction
- Analyze, interpret assessment results according to the patterns of SI function and dysfunction
- Relate the data obtained through the application of the instruments with the difficulties of occupational performance of the individual
- Identify client-centered goals and objectives from presenting concerns linked to the interpretation
- Create the intervention plan based on the evaluation performed
- Determine how the intervention will be conducted and effect various contexts, in children identified with sensory dysfunction

Module 6

Evidence-based ASI Intervention Hands-On Practice and Review

#### **Course Description:**

Module 5 introduces the research and manualized methods of ASI intervention including the Fidelity to ASI Intervention measure that assists researchers and clinicians to distinguish between interventions that are faithful to the principles of ASI and those that do not meet the criteria.

In Module 6, learners are taught intervention strategies specific to Ayres Sensory Integration®. The trainings leading to competency teaches implementation of an intervention plan based on the interpretation of the results of tests as demonstrated and discussed. The clinical reasoning and resolution of problems of a specific case study are used by all participants.





#### **Learning Objectives:**

Following these courses, participants will be able to...

- Apply clinical reasoning in the design and implementation of intervention for individuals with sensory integration difficulties or dysfunction
- Link the hypothesis from the assessment with therapeutic proximal goals toward meeting proximal, participation-related outcomes
- Use dynamic assessment while working with clients to refine the intervention during treatment
- Name the process elements of the ASI Intervention Fidelity Measure
- Describe the way in which the process elements interact during a direct intervention session
- Explain the relationship between the activities and the facilitation of adaptive responses
- Explain the importance of the client's motivation and active involvement during the intervention
- Discuss the benefits and limitations of ASI intervention with a wide variety of diagnostic groups, ages, and types of difficulties
- Demonstrate the way in which sensory strategies are implemented in various contexts, including the home, school, and the community

#### Dr. Susanne Smith Roley (OTD, OTR/L, FAOTA)

Susanne is an occupational therapist with over 40 years of experience in pediatric practice, specializing in child development, sensory integration, learning difficulties, visual impairment, and autism. She obtained her BS in OT at Indiana University, her MS in Allied Health Sciences at Boston University, and her doctorate in occupational therapy (OTD) at the University of Southern California.

Susanne is in private practice in Orange County, California serving children and families through evaluation and consultation services. She was certified in sensory

integration in 1977, studied under Dr. A. Jean Ayres in 1981, and in 1998 co-founded and then directed the USC/WPS sensory integration certificate program for 14 years. She is currently the co-founder and president of the nonprofit organization, Collaborative for Leadership in Ayres Sensory Integration (CLASI), providing a sensory integration certificate education program, offered in many countries around the world.

Susanne is a past chair of the Commission on Practice and the Sensory Integration Special Interest Section for AOTA and a contributing author of the Occupational Therapy Practice Framework Domain and Process, 2002 and 2008. She is an internationally recognized author and lecturer and co-editor of the books, Understanding the Nature of Sensory Integration with Diverse Populations and Sensory Integration: Applying Clinical Reasoning to Diverse Populations. She is a fellow of the AOTA and recipient of the AOTF Virginia Scardina Award of Excellence and AOTF A. Jean Ayres Award.

#### Dr. Stephen Tsz Man Chan (OTD, MSc, BSc (Hons) in OT, HKROT)

Stephen is an occupational therapist based in Hong Kong and the founder of CREST Child Rehabilitation and Education Service Team. He focuses on providing occupational therapy services to children with various developmental and learning challenges.

In addition to his clinical work, Stephen teaches professional training courses on various topics such as Ayres Sensory integration, Beckman Oral Motor




#### **Course Sequence:**

The Modules build upon each other. Module 1 is designed to help participants become conversant in theory

related to sensory integration and serves as an introduction to the forms of assessment taught in Module 2 and 3. Module 2 and 3 are a prerequisite to Module 4, which focus on the interpretation of test results, e.g., EASI, SIPT results. Module 5 and 6 builds on the elements introduced in all of the previous Modules.

We recommend participants to attend the Modules in sequence and believe those who take the Modules out of order will be at a disadvantage. However, if participants need to take the Modules out of sequence, special approval from program coordinator is required.



#### **Certification:**

Participants who fulfill the requirement of completing all 6 modules including the assignments are eligible for applying the Certificate in Ayres Sensory Integration® issued by Collaborative Leadership in Ayres Sensory Integration (CLASI). This program is adhering to the *standard of International Council* for Education in Ayres Sensory Integration (ICEASI). Please be aware that ALL 6 Modules must be completed within a 5-year time span in order to qualify for
